

Youth Service Matrix Corrections



Service	Correction*
401-PARTNER PROGRAM REQUIED: Registered Apprenticeship Program (RAP)	Revised definition
445-Other Non-Occupational Skills Training	Performance measure corrections: service puts Youth in Employment & MSG measures, but <u>not</u> the Credential measure

Career Exploration & Customer Flow Update





1

Enter the 3 non-enrolling activities (468, 469 & 470) before adding the Vocational Exploration service.

2

Vocational Exploration must be an objective in the Individual Service Strategy (ISS).

Use the "Research LMI & Occupations" pre-defined objective.

3

Enter the 431-Vocational Exploration service & case note *after* developing the ISS & discussing the vocational exploration with the participant.

No Youth Elements before 3/10/23



- Youth enrolled before 3/10/2023 with no Youth Element services:
 - Youth element services must be provided and entered in the system

OR

- The Youth must be exited
- These Youth are enrolled in WIOA and are in the performance measure.
- Do not use the "YOUTH ONLY-No Enrolling Service exit reason.

Youth Enrollment Comparison

Must have at least one Youth Element Service before providing any <u>new</u> support services, incentives, or initial ITA requests.	Must be enrolled before providing any support services, incentives, or initial ITA requests.
New 470-Career Planning (Case Management) activity does not extend the 90-day exit period.	New 470-Career Planning (Case Management) activity does not extend the 90-day exit period.



- Our "Example Three" participant's "Youth Program Entry Date" matches the Actual Begin Date of the 1st Youth Element service (431-Vocational Exploration).
- The "PE" (Triggers Program Entry) column has a check mark indicating it's an enrolling service.
- The Service Name includes the Youth Element number (YE 13).

- Use exit reason "YOUTH ONLY-No Enrolling Services".
- This Exit Reason is only applicable for Youth added after 3/10/2023.


